## 申請細則及注意事項 Rules and Notices for Application :

1. 申請人必須為荃威花園業主，租客須由業主代為申請或以書面授權申請(請業主填妥後頁之授權書)。

Applicant should be the flat owner of Allway Gardens. A written authorization should be submitted for tenants to apply for octopus entrance. (Please submit the authorization letter attached.)

2. 八達通如有遺失或被竊，請盡快以書面向荃威花園管業處報失。

If the card was lost or stolen, the card holder should contact the Management Office to report in writing as soon as possible.

3. 持證人必須為荃威花園業主或住戶。

The card holders must be the owners or the residents of Allway Gardens, or one who has the authorization.

4. 每戶免費申請限額為 6 張，隨後再增加或修改登記名額每張八達通需要額外支付港幣\$50 行政費，不設退還。

The initial application limit is 6 cards per household, free of charge. Afterward, each additional or replacement of Octopus card requires an extra administrative fee of HKD \$50, and the payment is non-refundable.

5. 荃威花園管業處有權拒絕不符合要求的申請。

The Management Office of Allway Gardens has the right to reject the application.

6. 荃威花園管業處保留最終決定權。

In the case of any dispute, the decision of The Management Office of Allway Gardens shall be final.
